
Dear Sir,

This has reference to your application requesting for allotment of common DPD code to avail DPD facility to receive your import containers from the all the terminals of JNPA. In line with the Public Notice 69 /2018 and PN 71/2021 issued by Jawahar Customs and/or permission issued by Jawahar Customs, Common DPD code allotted to you as indicated in **Annexure – A** subject to following conditions:

1. This registration is made only for the purpose of handling containers at JNPA terminals.
2. You shall ensure that (if containers are selected for scanning by Container Scanning Division (CSD)), the selected containers loaded on trailers shall be presented to CSD Yard inside the respective terminal by the Importer/ CHA.
3. You shall open PD account for carry out transactions with respective terminals
4. You should carry registration on NLP website under link <https://nlpmarine.gov.in/> to received PCS EDO.
5. Any change in the particulars including the address, email id, name of authorized signatory, name of Managing directors, Directors, Executive directors, Non-executive directors, Shareholders should be brought to the notice of this Office immediately along with contact details along with documentary proof. The Common DPD code allotted to you should be indicated in all correspondence with JNPA.
6. You will be required to follow the guidelines stipulated by JNPA from time to time. This department trusts that you will maintain the standards expected from JNPA so that you continue to enjoy the benefits of the business association.
7. Permission for DPD facility may be withdrawn by JNPA at any time in case you fail to adhere to any of the above conditions, (including permission withdrawal by Jawahar Customs or cancellation of AEO certificate).
